What we do	
How does Prancer Capital Corporation protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Prancer Capital Corporation collect my personal information?	We collect your personal information, for example, when you apply for financing or provide employment information give us your wage statements or give us your contact information give us your income information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only sharing for affiliates' everyday business purposes – information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Other important information

Notice to California Residents. Residents of the state of California do not have to take any further action to limit the sharing of information - such limits are already in place. We will not share any of your non-public personal financial information (other than as permitted by law) with our affiliates, or with outside companies, unless you first authorize us to do so.

Notice to Vermont Customers. We will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
